*We the people of Te Hapu o te Wakaminenga wahi o Maniapoto of Nu Tireni, Solemnly declare in front of the Creator. Lawfully constituted under the tikanga of Hapu of our territory “Nu Tireni”.*

*Standing in the light of the Creator, Internationally recognised proclaimed sovereign authority of our Mana and Tino Rangatiratanga.*

*Lawfully constituted in accordance with “He Wakaputanga o Nga Rangatiratanga o Nu Tireni 1835” with full acknowledgement of “Te Tiriti o Waitangi 1840” whilst exercising Hapu Tikanga within the territory of Nu Tireni*

Re: Trans Pacific Partnership Agreement (TPPA)

As a sovereign native tribal people of New Zealand the Hapu Rangatira (Chiefs) of Ngati Maniapoto New Zealand “Te Hapu o te Wakaminenga Wahi o Maniapoto o Nu Tireni” lawfully constituted under He Wakaputanga o Nga Rangatiratanga o Nu Tireni 1835 ( New Zealand Declaration of Independence 1835) and signatories to Te Tiriti o Waitangi 1840, we are writing to inform you;

(a) that the New South Wales Convict Colony Government (which also calls itself the “New Zealand Government” or ” the Crown” or “NZ Inc” or the “New Zealand Company” or “Queen in Right of New Zealand Inc”) and unlawfully occupying our country and posing as “Her Majesty the Queen of England Elizabeth II (who is our treaty partner under Te Tiriti o Waitangi 1840) is conducting negotiations of national importance without consulting the country sovereigns Ngā Rangatira o Ngā Hapū o Nu Tireni (The United Tribes of New Zealand) who collectively hold tino rangatiranga or effective right of veto in matters of state, and that this fact renders the TPPA negotiations null and void on New Zealand’s part because the New South Wales Convict Colony Government (which also calls itself the “New Zealand Government” or ” the Crown” or “NZ Inc” or the “New Zealand Company” or “Queen in Right of New Zealand Inc”) does not have the due authority to conduct such negotiations without the agreement of the Ngā Rangatira o “Te Hapu o te Wakaminenga Wahi o Maniapoto o Nu Tireni” who are part of Ngā Hapū o Nu Tireni (The United Tribes of New Zealand), which has not been given

b) that the New South Wales Convict Colony Government (which also calls itself the “New Zealand Government” or ” the Crown” or “NZ Inc” or the “New Zealand Company” or “Queen in Right of New Zealand Inc”) is in breach of its Treaty obligations by virtue of its actions above, and is acting unconstitutionally and unlawfully in terms of international law

c) that the sovereign native people in New Zealand have been exhausting their legal remedies via the Waitangi Tribunal, but that the New South Wales Convict Colony Government (which also calls itself the “New Zealand Government” or ” the Crown” or “NZ Inc” or the “New Zealand Company” or “Queen in Right of New Zealand Inc”) has been attempting to deny remedy by claiming authority to act unilaterally and imminently, which authority it demonstrably does not have as shown by the Waitangi Tribunal Claims numbers WAI 2522, 2533, 2530, 2531, 2532, 2533, 2270 and 1427 and also by the November 2014 findings of the Waitangi Tribunal Inquiry into the WAI 1040 Claims at <http://www.justice.govt.nz/tribunals/waitangi-tribunal/Reports/he-whakaputanga-me-te-tiriti-the-declaration-and-the-treaty-the-report-on-stage-1-of-the-te-paparahi-o-te-raki-inquiry>







d) that Te Hapu o te Wakaminenga wahi o Maniapoto of Nu Tireni (Maniapoto Hapu Congress of New Zealand) are now exercising their right of veto to declare the negotiations void with respect to New Zealand’s involvement in the formation of the Trans-Pacific Partnership Agreement, and that this situation of veto will remain until we are fully informed of, and explicitly agree to the terms of the Partnership (which have hitherto been kept secret).

Further we of Te Hapu o te Wakaminenga wahi o Maniapoto of Nu Tireni (Maniapoto Hapu Congress of New Zealand) *request and require* that the other States do not sign the Trans-Pacific Partnership Agreement with the New South Wales Convict Colony Government (which also calls itself the “New Zealand Government” or ” the Crown” or “NZ Inc” or the “New Zealand Company” or “Queen in Right of New Zealand Inc”) or its representatives, as in doing so those States would be assisting in a process that undermines the Constitution of New Zealand.

**Null and Void**– In the event where a Trans-Pacific Partnership Agreement has already been signed with New Zealand, nga rangatira (chiefs) of Te Hapu o te Wakaminenga wahi o Maniapoto Nu Tireni (Maniapoto Hapu Congress of New Zealand) inform the other TPPA signatories that the Agreement is null and void on the grounds above and must be rescinded on New Zealand’s part; and further that our assertions that the New South Wales Convict Colony Government (which also calls itself the “New Zealand Government” or ” the Crown” or “NZ Inc” or the “New Zealand Company” or “Queen in Right of New Zealand Inc”) did not have the right to act unilaterally in signing this agreement or other international agreements is a matter of public record and is an international incident.

SUCH IS OUR WILL ~ SO BE IT

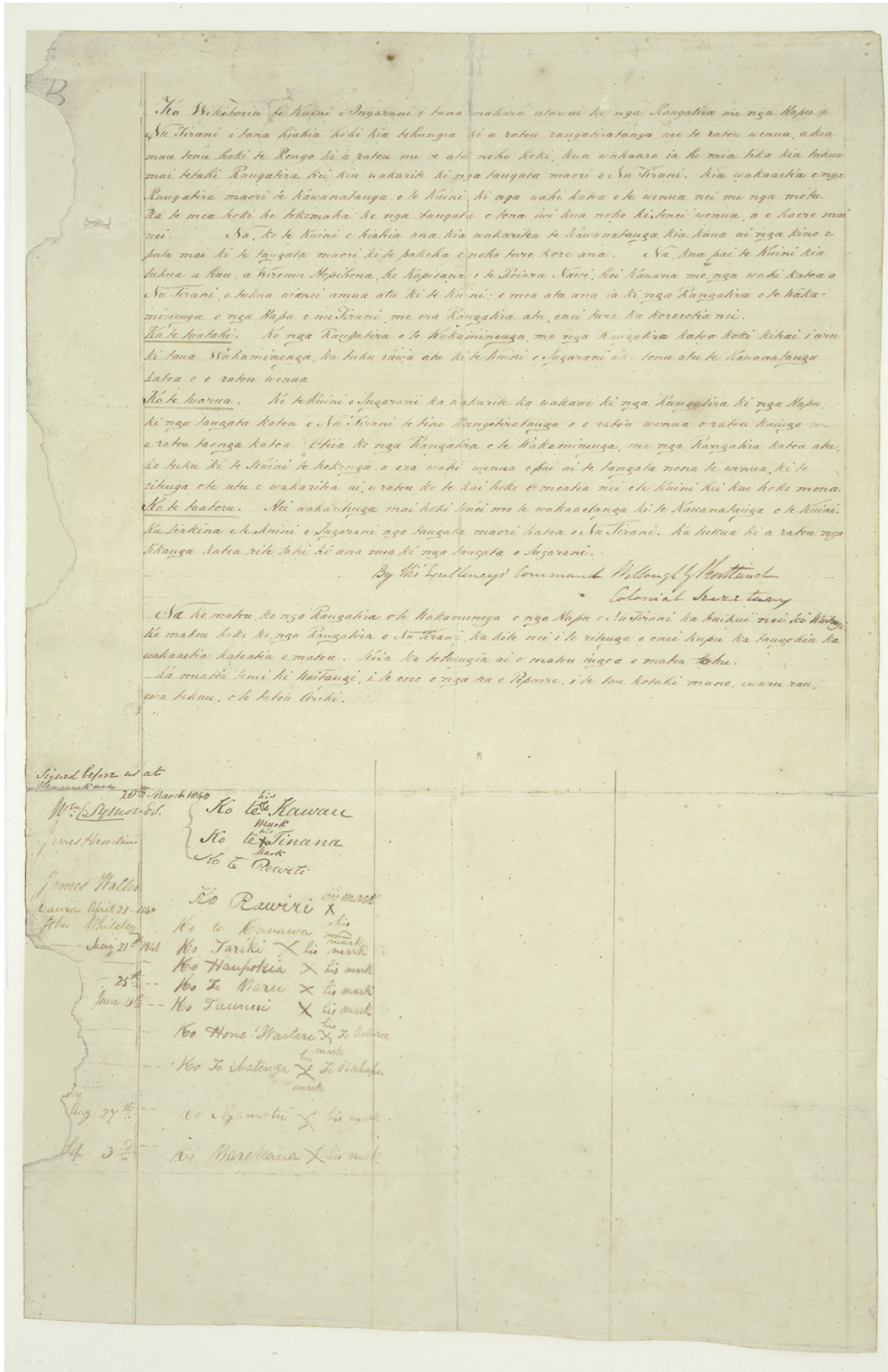
